- Current, valid Permanent Resident Card (USCIS form 1-151 or 1-551)
- Current, valid military identification card for active duty soldiers or veterans
- U.S. Certificate of Birth Abroad issued by the Department of State (DS-1350) or a Consular Report of Birth Abroad (FS-240)
- Current U.S. Passport
- U.S. Certificate of Citizenship (USCIS form (N-560 or N-561)
- U.S. Certificate of Naturalization (USCIS form N-550 or N-570)

### <u>In addition to being lawfully present in the United States, you must meet the in-state tuition</u> requirements to warrant an in-state tuition classification.

Any student who cannot be verified as lawfully present in the United States is not eligible to be considered for in-state tuition, regardless of how long he or she has lived in Georgia. In addition to being lawfully present in the United States, students must meet the in-state tuition requirements as outlined in TCSG Board Policy and Procedure V.B.3 to warrant an instate classification. Students that are initially classified as out-of-state and successfully petition to have their residency changed to in-state also have to meet the verification requirement.
