The Automation and Robotics Technology Degree AAR3 program was designed to equip graduates with a versatile skill set for a variety of manufacturing positions that are industry driven, including Plant Maintenance Technician, Industrial Electrical Maintenance Technician, Mechanical Maintenance Technician, Mechatronics Technician, Control Technician, Robotics Technician, with the emphasis on installing, diagnosing, maintaining, and repairing electromechanical machinery and Robotics. The planned sequence of courses prepares students to complete the Associates Degree within two years.

Automation and Robotics Technology positions have a starting salary \$65,000 a year. The current industry demand for Automation and Robotics Technicians is a high Priority in Industry as more companies add more Automation and Robotics to their production units. Our success rate with student placement is 100% of graduating students.
