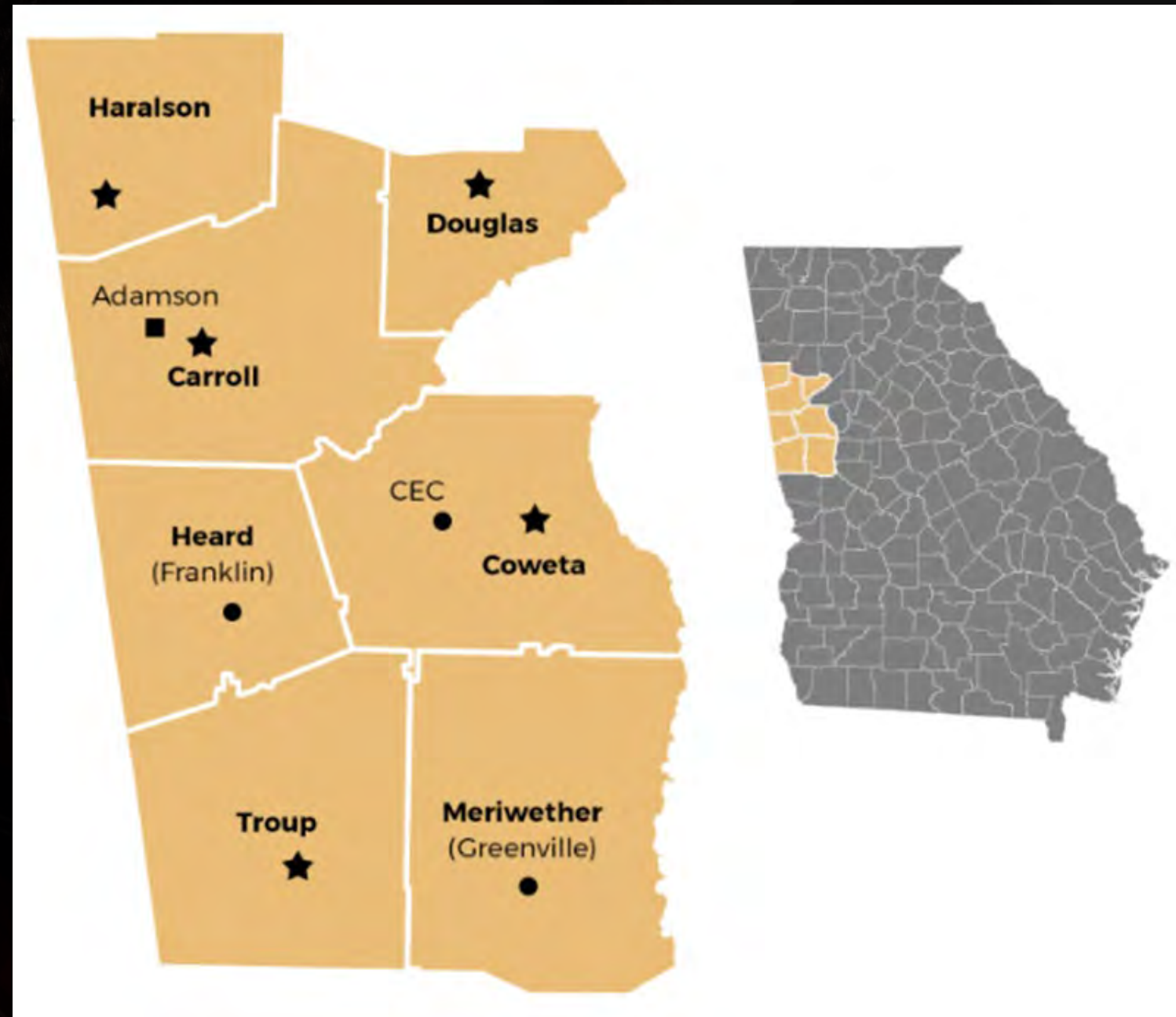

Dual Credit means.....

- You are using college courses to meet your high school graduation requirements.
- You are getting a jumpstart on your post-secondary training.
- Failure to complete your Dual Enrollment classes CAN have a negative impact your high school graduation requirements.
- Failure to complete your Dual Enrollment classes CAN have a negative impact your high school sports eligibility.

DUAL ENROLLMENT FUNDING

- * Covers occupational or academic core for 11th and 12th graders. Covers occupational courses for 10th graders (academic core for 10th only if SAT 1200 / ACT 26).
- * Covers tuition cost up for up to 30 hours of coursework (roughly 10 classes).
- * Limited to 15 hours per semester total but may attend multiple institutions.
- * Student completes a Dual Enrollment application on the [GAfutures](https://www.ga-futures.org/) website each year.
- * WGTC waives mandatory fees for dual students, but there may be some small fees, such as lab or supply fees, uniforms, welding shields, etc.
- * Hours used under the Dual Enrollment program do NOT count towards HOPE hour caps limits.
- * In cases where students will exceed the 30 hours of dual enrollment hours allotted, HOPE Grant may be available to cover additional courses in certain circumstances, such as CTAE courses or programs identified as high-need in Georgia. *Additional proof of GA residency may be required.*
- * Students must meet GA residency and Lawful Presence Requirements.

Accelerated Career Pathway

- * Student can use the Accelerated Career Pathway to complete High School, using an AAS degree, a technical diploma, a certificate program leading to licensure, or 2 TCCs in one of GA's high demand field.
- * Student must complete the GSFAPPS on the GAFutures website to apply for ACE Grant Funding.
- * Currently, there is no cap hour limit for the ACE Grant Program.
- * Student MUST be identified as Accelerated Career by their High School to participate in the ACE program.
- * ACE Grant Hours used will count towards the DE 30 hours cap, if the student moves from Accelerated Career to regular Dual Enrollment.
- * Students must meet GA residency and Lawful Presence Requirements.



Common Instances When Student May Owe a Balance*

Additional Fees are Required. Dual Enrollment funding covers 100% of tuition expenses and WGTC waives mandatory fees; however, many courses have additional fees, such as lab fees or program fees and program-specific requirements that have a cost associate with them, such as background checks.

Incomplete or ineligible Funding Applications. Failure to complete a required GSFC Funding application, to provide additional documentation, if requested, or to meet GSFC funding eligibility requirements may result in denial or loss of funding.

Exceeding the 30 hour Dual Enrollment Funding Limit. Students can receive Dual Enrollment Funding for up to 30 credit hours of coursework.

Taking Courses not listed on the GSFC approved Course Directory. Student may only receive Dual Enrollment Funding for courses listed on the GSFC approved course list.

Not meeting the Financial Aid Satisfactory Academic Progress Policy. All students receiving state financial aid funds, including Dual Enrollment Funding, are required to meet the College's Satisfactory Academic Progress Policy.

Academic Standing Policy: One term of failure to earn a 2.00 overall GPA will result in Academic Probation. A second term below a 2.00 overall GPA will result in Academic Suspension. Once on Academic Suspension, you are required to sit out a term.

TECHNOLOGY

TECHNOLOGY

01 Know your login credentials

Your email address and your Student (Banner) ID can be found inside your Student Portal.

02 Single Sign On

You will use the same login credentials for all WGTC applications (Blackboard, eCampus, Email, Office 365 & BannerWeb).

Your **username** is your ENTIRE email address. Example: fakestudent4@student.westgatech.edu

Your **password** is initially set to your 8-digit birthday. Example: 05012007 (no dashes)

03 OKTA

This is WGTC's multi-factor authentication system. You MUST set up OKTA first to be able to login successfully. On your first login attempt, you will be prompted to set up your preferred authentication method. It is STRONGLY recommended that you use Security Questions.

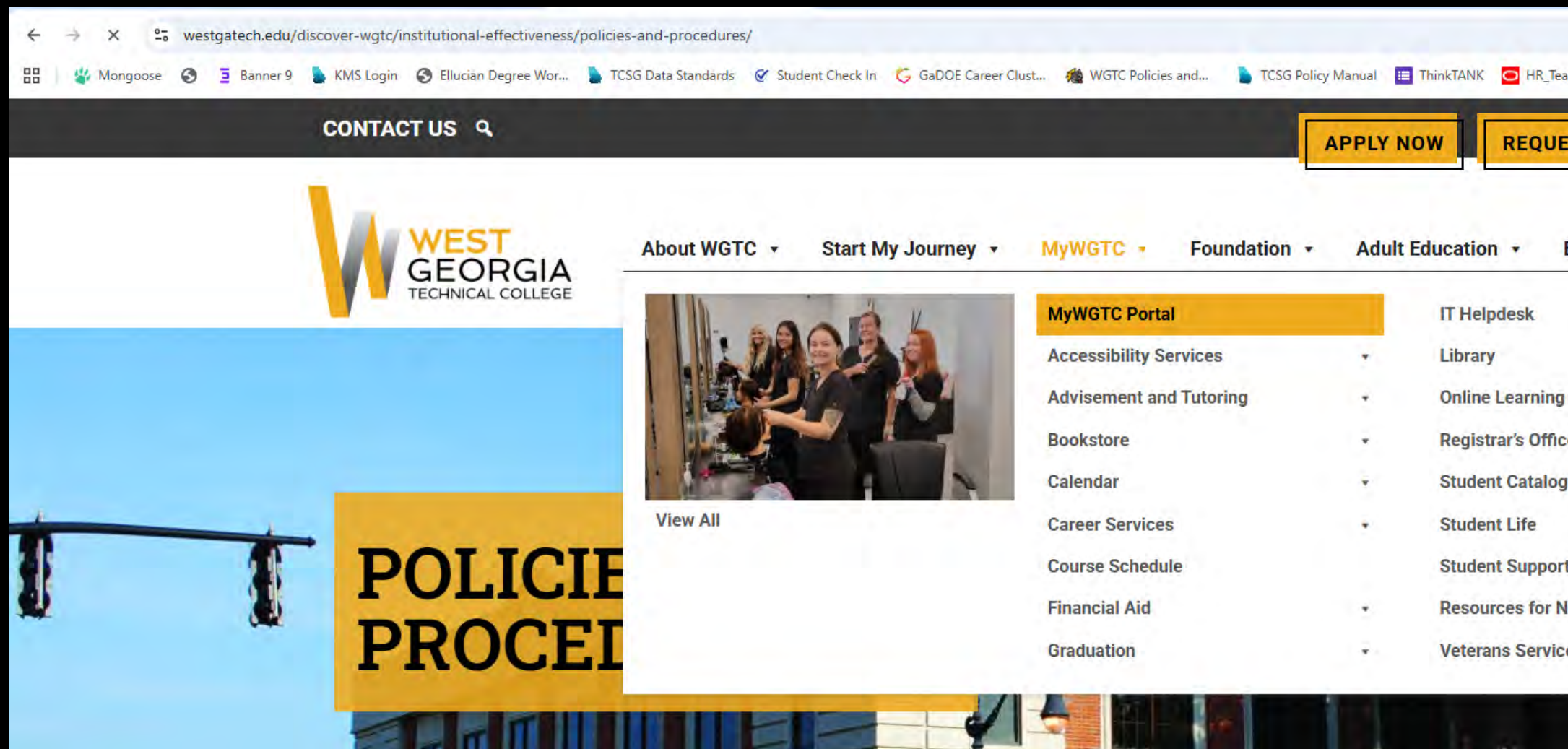
04 myWGTC Dashboard

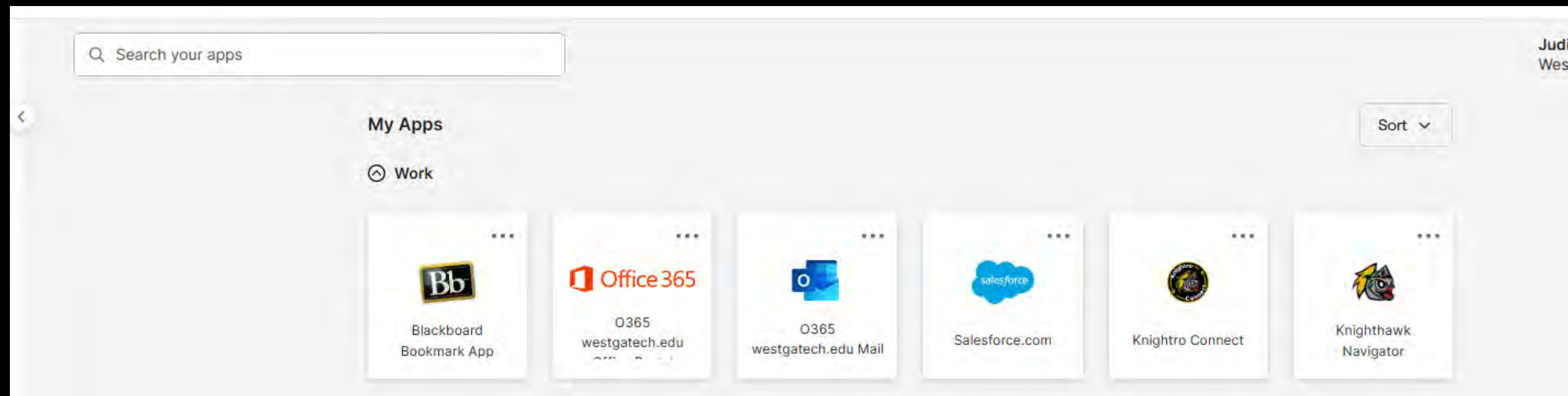

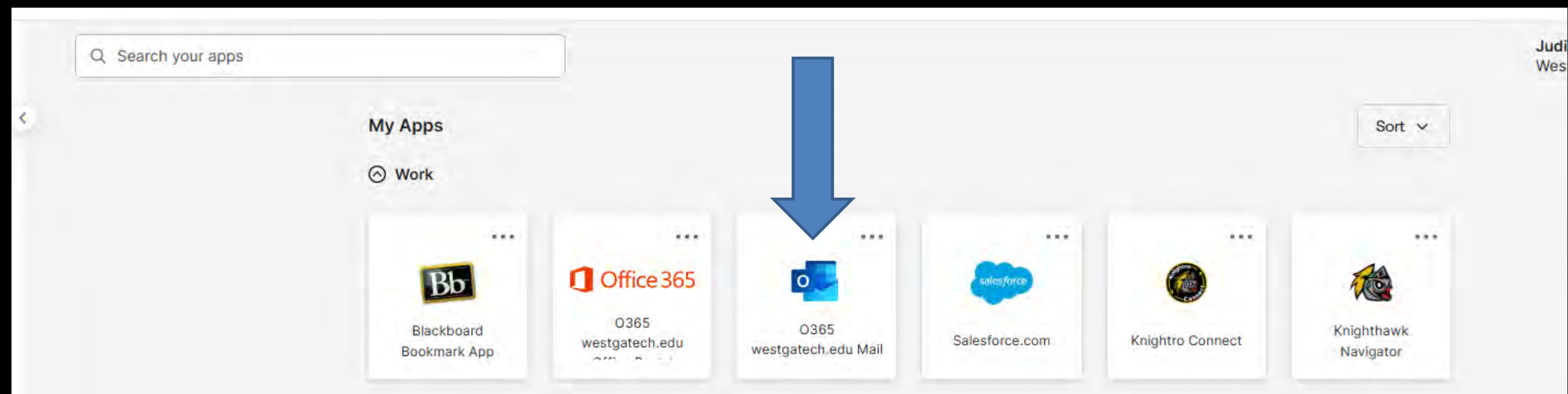

Adjusting Your Class Schedule

- Drop/Add

You can adjust your schedule the first 3 days of the term with no academic penalty.

- Withdrawal

Beginning the 4th day of the term, students can request to be withdrawn by emailing their WGTC HS Coordinator. Student receives a W grade on their academic transcript.

- High School Approval Required

Your Counselor **MUST** approve any schedule changes.

- Allowed only 1 withdrawal

If you accumulate a total of 2 withdrawals you are no longer eligible for Dual Enrollment Funding. (ACD allows withdrawals, but SAP rules still apply).

- Repeating a course

Dual Enrollment Funding does not pay for a repeated course. (ACD allows repeats).



FINANCIAL AID

ALL Dual Enrollment Programs require a student to maintain **Satisfactory Academic Progress (SAP)**.

- MUST Maintain a 2.00 overall GPA (C - 70)
- MUST Complete 66.6% of your attempted courses

Failure to meet SAP requirements will result in Financial Aid Probation (one term) and Financial Aid Suspension (second term).

Students on Financial Aid Suspension CANNOT receive any Dual Enrollment Funding, and would be required to self-pay for courses.

FINANCIAL AID

Bank Mobile Refund Preferences

Students who exceed their 30 hours of Dual Enrollment Funding and choose to use the HOPE Grant & HOPE Career Grant to continue taking courses may receive funds in excess of tuition expenses.

These students are required to select a Refund Preference through BankMobile. If you need to select a Refund Preference, you will receive a code from BankMobile through your WGTC email account with instructions on setting this up.

Selective Service Registration



Male students who are or will be 18 years old during the school year are **REQUIRED** to register with Selective Service, in order to receive Dual Enrollment Funds.

This is a Federal and State requirement.

Online Registration can be completed at www.sss.gov beginning 6 months prior to your 18th birthday.

NOTE: Failure to register, if required, will cause the student to be responsible for all tuition charges for the semester.

Textbooks

- Textbooks are provided for students using Dual Enrollment Funding or Accelerated Career. **DO NOT purchase your own textbooks.** (Only students who have exceeded their 30 hours of DE funding should purchase books).
- Visit to the WGTC Bookstore, with your class schedule, and identify yourself as a Dual Enrolled Student to obtain your textbooks. They will be provided at no charge.
- Some courses do not have physical textbooks. Refer to course syllabus to determine the textbook requirement for your course.
- Some courses use technology software and codes may be provided to you by dual enrollment or by your instructor. If you are unsure, please contact dualenroll@westgatech.edu.
- Physical textbooks that are borrowed **MUST** be returned in good condition by the last day of final exams. Failure to return borrowed textbooks or damage to books will result in a book replacement charge and a hold on your student account.

COURSE DELIVERY OPTIONS



Web-enhanced

A face-to-face course that uses a web-based component to supports classroom instruction, assignment or tests.



Hybrid

A course in which there is a mixture of structured, scheduled face-to-face class time and online delivery.



Online - Asynchronous

An online course where assignments are due weekly. No scheduled meeting time.



Online - Synchronous

An online course that has specific meeting times. The student is **REQUIRED** to be online during those times.

FERPA

Family Educational Rights to Privacy Act (FERPA)

Student records will not be made available to others except where permitted by law.

*The Dual Enrollment Funding Application provides student & parent acknowledgement that the student's college information will be shared with the High School.

*In order for the College to share information with a parent, the student must complete the FERPA Consent Form to authorize providing information to the parent.

- You need a photo ID and proof of your class registration to obtain a Student ID.

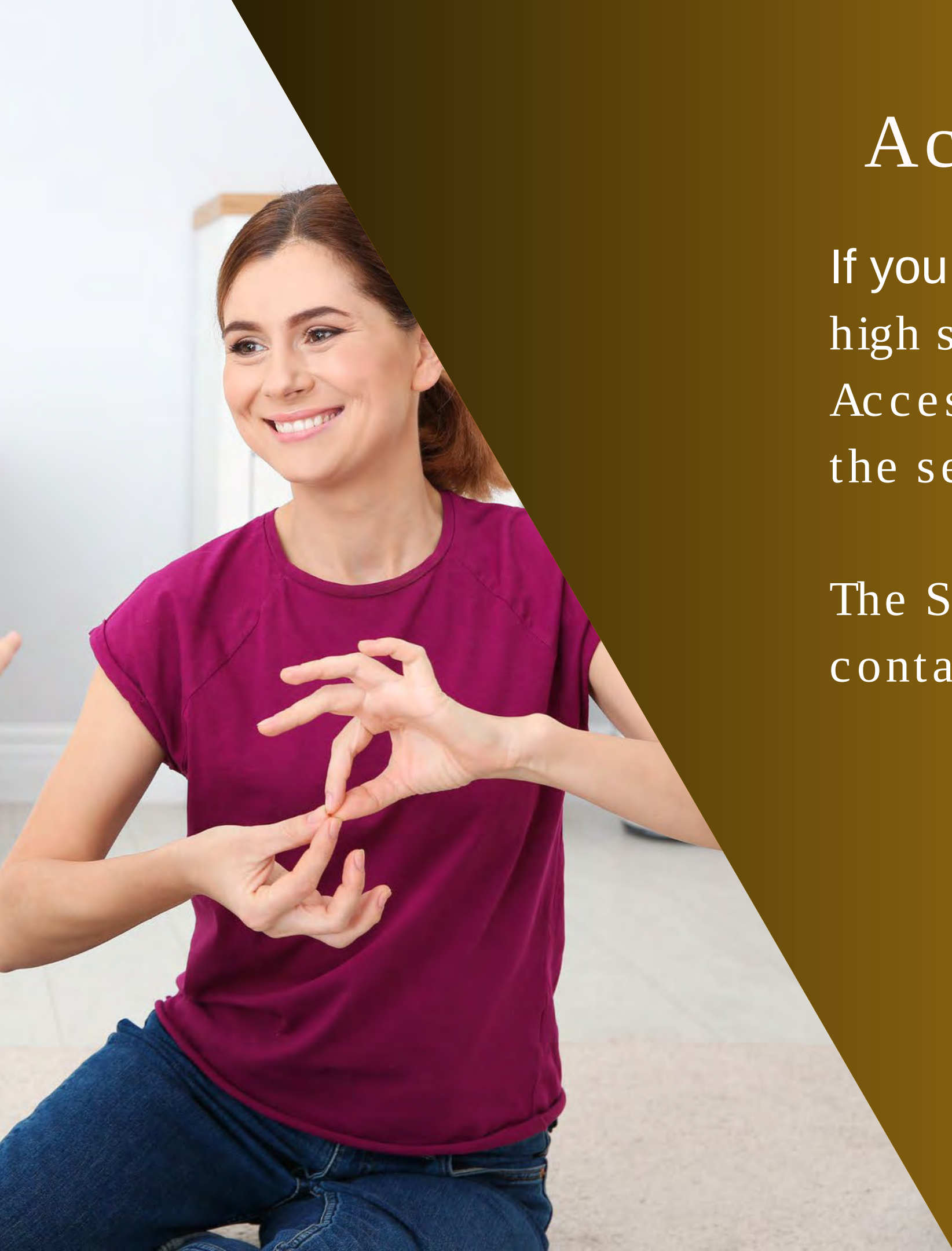
- All students and staff must have a WGTC car hangtag for on -campus parking.

If you are currently under an IEP or 504 plan with your high school, you will need to contact WGTC's Accessibility Office to secure accommodations BEFORE the semester begins.

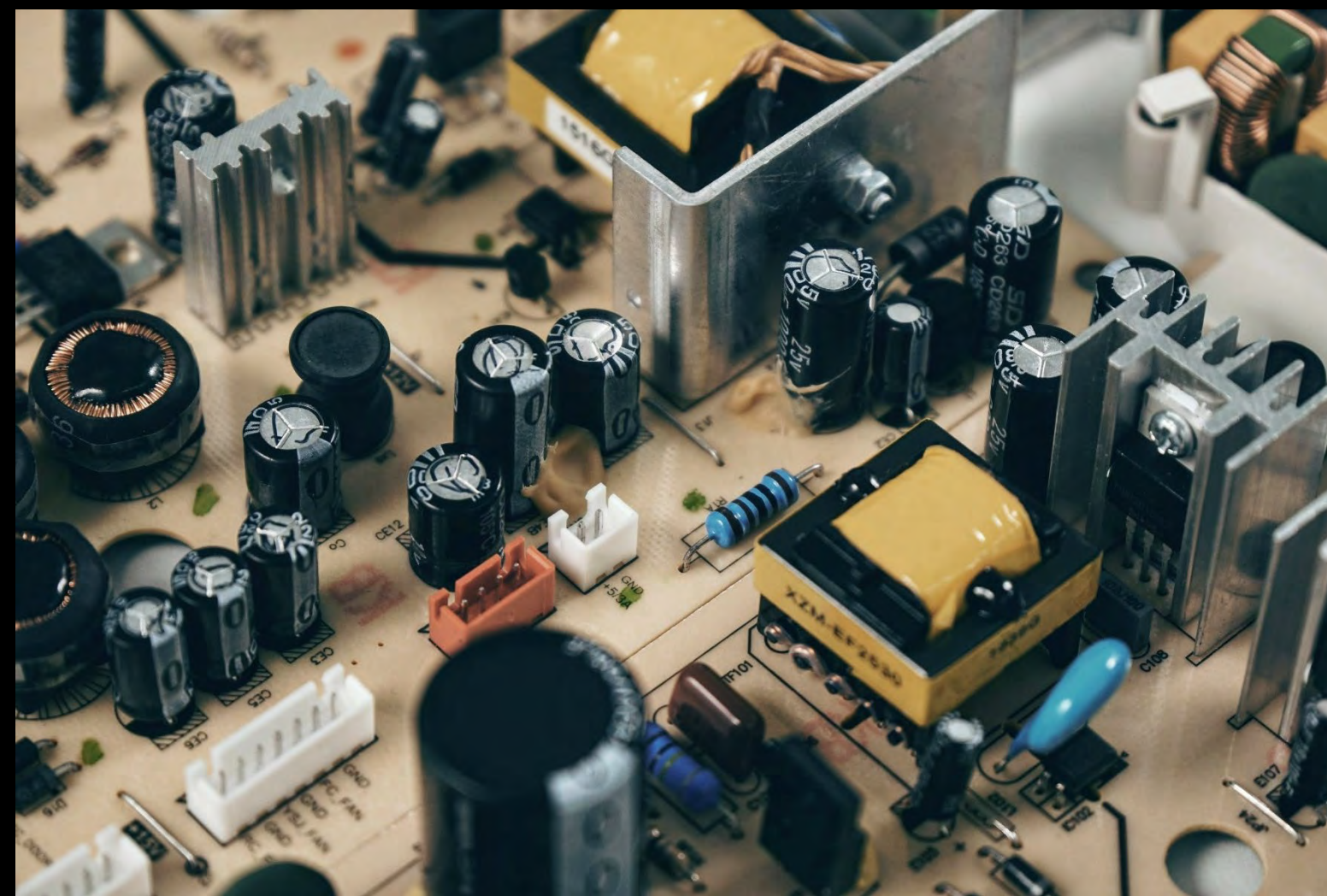
