

## Industrial Instrumentation Technician Certificate (IIT1)- 22 Credit Hours

## **Program Description:**

The Industrial Instrumentation Technician certificate program provides knowledge and skills to install, configure, calibrate, repair, maintain, and troubleshoot electrical instruments and equipment. Emphasis is placed on principles and practices of instrumentation for industrial process control systems and for communications, networking, and signal transmission systems. Graduates may find entry-level employment as instrumentation technicians, electrical technicians, instrument mechanics, or industrial maintenance technicians in a variety of settings that require automated manufacturing skills. Initial salaries are estimated to begin at \$48,180. (BLS.gov and-maintenance/ May 2022).
