The Basic Shielded Metal Arc Welder certificate program prepares students for Tyler Layton, Instructor careers in the welding and joining industry. This certificate emphasizes arc welding in the flat position and is prerequisite to the advanced certificate, OSM1: Advanced Shielded Metal Arc Welder. Graduates are employable at an entry level in the welding field. Salaries in this occupation are estimated to start at \$35,380 per year (BLS.gov May 2022).
